Please read through the information provided below regarding personal entry times for use of Tokyu Sports Oasis. Place check marks in the boxes as appropriate () , and add your signature.

1	<ul style="list-style-type: none"> I have confirmed the ordinary opening hours (with staff present) and personal entry opening hours for the Tokyu Sports Oasis store I intend to use, and understand/accept that staff will not be present outside of ordinary opening hours.
2	<ul style="list-style-type: none"> I accept that people under the age of 18 (including high school students) cannot use the facility during personal entry times. People under the age of 20 require the consent of their parent or guardian.
3	<ul style="list-style-type: none"> I pledge to only use the authorized area of the facility during personal entry times.
4	<ul style="list-style-type: none"> Please conduct any procedures (e.g. for discontinuation or change of membership) during ordinary hours (with staff present). No procedures can be handled during personal entry times. * To discontinue membership, complete the required procedures at the front office of the facility by the 10th of the month you wish to discontinue (or the previous working day if the facility is closed on the 10th; must be done during ordinary hours (with staff present)). If you fail to apply by the above date, your discontinuation will occur in the next month, and the membership fee for the next month will be deducted through automatic bank transfer.
5	<ul style="list-style-type: none"> I have read and confirmed the Instructions on the Use of Tokyu Sports Oasis 24Plus Facilities, and listened to the explanation of the club's training machines and equipment and IC card (or band). I understand and accept the instructions.
6	<ul style="list-style-type: none"> I have sufficiently listened to and understood the explanation of the potential dangers in using the equipment of the club.
7	<ul style="list-style-type: none"> I accept that the club and the facilities will hold no responsibility whatsoever for any loss of property, theft, injury, or other accident occurring in the facilities, unless the accident is the fault of the club.
8	<ul style="list-style-type: none"> I pledge that there is no problem with me using this club in terms of my past history of disease and current state of health.
9	<ul style="list-style-type: none"> I understand that the staff will not be present during the personal entry times, and I am clear that I need to use the club with health management under my own responsibility, with sufficient understanding of the risks involved in exercising on my own.
10	<ul style="list-style-type: none"> I pledge that any injuries or other harm that may occur to me as a result of using the club is entirely my own responsibility.
11	<ul style="list-style-type: none"> I pledge to pay compensation for any harm I may cause to the equipment and machines of the club during the personal entry times, or to other members.
12	<ul style="list-style-type: none"> I pledge not to use the club for any purpose other than exercise. I pledge not to use it as a place of accommodation, a place for eating and drinking, or as a place to sleep or doze.
13	<ul style="list-style-type: none"> I pledge not to act in ways that may cause inconvenience to residents living near the club.
14	<ul style="list-style-type: none"> I pledge my consent that the club, club staff, and other persons involved with the club shall not be liable for any injuries, death, or other result, if occurs to me, through use of the club (excepting in cases where the club bears responsibility), and that I bear full responsibility for any results regardless of whether they could be predicted or not. I pledge that neither myself nor my family, heir, legatee, or other interested party shall file a claim against the club, club staff, and other persons involved with the club originating in my use of the club.

I have read and understood the above matters, and wish to become a member. I agree that if the above matters are violated, the Company may prohibit me from using the facility or expel me from membership, and in such a case I will not make any objections.
