Billing from SMBC Finance Service Co.,Ltd. to members and payment of fees will be handled via automatic bank transfers.</p> <p style="margin-left: 20px;">【Tokyu Card credit card】 Monthly membership fees and other payments will be paid by ongoing automatic bank transfers based on agreements with credit card companies via credit cards registered with the Company according to the set method. The Company will not issue invoice or receipts. The automatic bank transfers will continue as long as no notification for a change is made.</p> This is a membership-based club. Membership fee will be paid even for months in which the Facilities are not used. To discontinue membership, complete and sign the form at the front desk of a facility by the 10th of the month you wish to stop being a member (or the previous working day if facility is closed on the 10th). (In the case of the Aoyama facility, by the 9th (or the previous working day if closed on the 9th)) If you fail to apply by time to above date, the automatic bank transfer for the monthly membership fee will be paid, and your membership will stop in the following month. Failing to pay membership fee or other fee or ignoring payment reminders may lead to expulsion regardless of the wish of the member. Payments in arrears will be received in full at that time. Admission fee and membership fee, once paid, will not be refunded for any reason. Please note that the facility can be used from the day the membership begins. So even if the bank transfer procedures are not completed. Follow the instructions to submit the required documents immediately.

6. be of a sufficient age as defined by each facility, or if underage, have been specially approved after a review by the Company.
7. have the specified document (including electronic records) giving permission from their parents or guardians for their entry if they are under 20 years of age. In such cases, the parents or guardians must share responsibility with the applicant based on these terms of use, rules, and other regulations set by the Company.

3. Restrictions on provision to third parties

4. Disclosure, correction, or deletion of personal information

The Company will act immediately on requests by customers to check or alter their personal information as held by the Company, within a reasonable and necessary scope.

The personal identity of the individual must be confirmed for the procedures.
